DIRECTIONS: Shake well before using. Spray directly onto bed bug infested areas including bedding and carpets. Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Repeat if infestation occurs, but not more than once every two weeks. Allow fabric to thoroughly dry before using. Follow-up in 1-2 weeks after application in same areas.

Coverage Area: A 12-ounce bottle of STOP BUGGING ME!™ will treat approximately 7 queen-size mattresses or 215 sq. ft. (an area of 10 ft x 21.5 ft).

For control of other crawling pests: Thoroughly spray all parts of the room suspected of harboring these pests. Pay special attention to hiding places such as cracks and crevices; behind and beneath sinks, stoves, refrigerators; around drains, pipes, plumbing, garbage cans; in cabinets, storage and other utility installation areas; along baseboards, door sills, frames and floors; behind bookcases; contacting insects with sprayer whenever possible.

PRECAUTIONS: Do not get in the eyes or on the skin. May cause stains and/or burn some susceptible plants. Always test a small, inconspicuous area before full application.
