TOOLS AND MATERIALS RECOMMENDED:

- 1. Tapping Block and mallet.
- Laminate Installation Tools (ROBERTS / Q.E.P. carry a complete line of tools. See your local Distributor or retailer).
- 3. Water dampened cloth.

APPLICATION:

- 1. Lay out panels according to manufacturer's instructions.
- Squeeze a 1/8-inch bead of adhesive into the grooves on both the side and end of each panel.
- 3. Fit the panels tightly, with the careful aid of a tapping block and mallet as required.
- 4. Allow the adhesive to cure for 24 hours prior to subjecting the floor to normal traffic.

CLEAN UP:

Immediately wipe off excess adhesive squeezed up between the panels with only a water dampened cloth.

Note: If the flooring manufacturer's instructions for application and clean up differ from above, installer may adopt their recommendations.

COVERAGE:

Typically expect this 473ml. bottle to be sufficient for 400 linear feet of panels.

VENTILATION: To enhance curing of adhesive, implement effective ventilation by opening windows and doors for an adequate supply of fresh air. Also, consider using window fans and/or air movers to bring fresh air in and to exhaust emissions to the outdoors.

LIMITATIONS:

1. Protect this product from freezing.
