Performance and Payment Bond: Tennessee law bars receipt at or before the time of execution of the contract of a deposit of more than ½ (one-third) of the contract price, unless the contract permits the home improvement contractor to furnish a performance and payment bond, lien and completion bond or bond equivalent covering full performance and completion of the home improvement contract and the bond is furnished by the home improvement contractor. The value of the bond/bond equivalent cannot be less than 1% of the net sales of the home improvement contractor's home improvement business in connection with home improvement work. If you do make the goods available to the seller and the seller does not pick them up within twenty (20) calendar days of the date of your Notice of Cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract.
