
King Water Filtration System Benefits and Features:

The KWF whole home water treatment system is a 3 stage organic filtration system that uses redox bacteriostatic and activated carbon media filtration to remove chlorine, harmful chemicals and metals from your household water supply.

The KWF system is managed by an automatic control valve that is programmed to backwash and cleans the system out automatically and has been preset at our factory, however these settings can be adjusted to your specific needs from the electronic control module timer. It will retain its' programming evening in a power outage as it has battery backup.

Our multi-polarity anti-scale magnet will protect your plumbing and appliances from scale build up and corrosion. As a matter of fact, it will not only prevent scale build up, but it will also help dissolve existing scale formation. Magnetic descaling works by converting the Calcium Bi-Carbonate ("Sticky Calcium") to Calcium Aragonite ("Non-Sticky Calcium"). Calcium Aragonite is water-soluble and is molecularly attracted to it, rather than being attracted to your plumbing fixtures and appliances. Calcium Aragonite also provides a natural alkaline balance to your drinking water assisting to better hydrate your body.

***When testing for your water hardness, the healthy minerals will purposely remain thus you will still have what is commonly called "hard" water in most areas. The KWF water treatment system does not remove these healthy minerals, but rather it treats these minerals so as that they are in a water soluble state giving you scale free water that is easier to clean with and will lengthen the life of your plumbing and fixtures, but most importantly it will provide healthy, mineral rich, spring quality, alkaline water for your household. ***



Evaporative Spotting:

Being that the KWF does not remove any nutrients from the water it may cause minimal spotting if accumulated water is left to evaporate on surfaces such as shower doors or countertops. Our system process will cause the minerals to lose their ability to adhere to most surfaces allowing any spotting to wipe off easier than regular hard water or sodium spots caused by water softeners. Not to be confused with a traditional ion-exchange water softener that requires regular maintenance and the reoccurring high cost of salt or potassium, our maintenance free system works differently. It does not remove the minerals (because minerals promote your good health). Instead it changes the minerals to water-soluble form that won't stick to your plumbing or cause hard water staining.

INSTALLATION INSTRUCTIONS:

- Connect Inlet/Outlet of system
 to the water loop or main line to
 the house. Make sure to
 identify correctly the Inlet and
 Outlet of system with the
 waterline.
- 2. Plumb system drain line.
- 3. Plug in system and set the time. (See operations manual)
- 4. Turn on the water to the system, make sure the system in in the "Bypass" position. (Figure 2)
- 5. Check for water leaks, repair if necessary.
- 6. Regenerate the system.
- 7. Slowly open the inlet side of the bypass and allow water to fill the tank. (Figure 4)
- 8. When water is flowing to drain, close the bypass inlet valve and let the system "soak" the media for 2 hours. (Figure 2)
- Regenerate the system again and slowly open the inlet valve, when water is flowing to drain slowly open the outlet valve. (Figure 1)
- 10. Let the system completely finish its backwash cycle. (It will do it automatically)
- 11. Start enjoying your new King Water Filtration System.

NORMAL OPERATION



BYPASS OPERATION



DIAGNOSTIC MODE




There will be no charge for parts to replace any portion of the system found to be defective during the term of the specified warranty period. Any replacement part deemed to be covered under this warranty will be exchanged for the same or equivalent replacement part or device at no charge to the original purchaser. Customer must provide proof of purchase for any warranty claims. Pure Water Technologies LLC shall not be liable for freight, and/or service charges, if any. Customer will be responsible for shipping charges of defective parts. Media warranty does NOT apply to private well installations, or non municipal water treatment. This warranty does not cover systems that are not set up to backwash, or systems that have manually had their factory backwashing cycle adjusted beyond the recommended time frame.
